

Minutes of the Ordinary Meeting held at Rosedale Reading Rooms on Thursday 13 September 2018 at 7:00pm

07466 Apologies for absence were received and accepted from Cllr L Dale and Priestman

07467 There were no Declarations of Interest in items on the agenda

07468 There were no members of the public present

07469 The Ordinary minutes of the meeting of the 16 August 2018 were approved.

07470 To consider planning applications and related correspondence received by the Clerk from NYMNPA and associated agencies since the previous meeting;

The Council noted that this application had been discussed at the previous meeting with a different description in the header.

The Council noted that since the publication of the agenda the Clerk had received a further planning application for consideration

07472 Car Park

07473 Village
