Minutes of the Rosedale Parish Council meeting held on 14 September 2011

06136 Questions and statements from the public

None were received.

06137 Declarations of interest

None were heard.

06138 Approval of minutes

The minutes of the Parish Council meetings held on 21 July 2011 and 11 August 2011 were

accepted as true records and signed by the Chair.

06139 Community Group update

No representative of the Community Group was present and no report had been received.

06140 Gill Lane issues

The Council heard that no response had been received regarding the date of closure of

Chimney Bank for resurfacing.

Resolved: To continue to press for a date.

06141 Broadband

The Council heard that the Clerk still intended to contact BT about broadband in Rosedale.

06142 Councillors' Training

Councillor Gage and the Chair both reported that they had been on training courses and said

that they found it valuable and recommended them to all Councillors.

06143 Allotments

The Council heard that the Clerk was still waiting to hear from some of the people on the list

for allotments.

06144 Highways issues

The Council heard that a sign to Rosedale at Hutton-le-Hole had previously been refused as

not all vehicles could negotiate Chimney Bank. The Council also heard that the issue of the

passing place at Brick Cottage would be investigated by Ian Birkett when he was next in the

area, and that any injuries caused by a road mirror on private land would be covered by their

insurance.

Resolved: To investigate whether the money could legally spent on such a mirror, how

much it would cost, and whether planning permission would be required.

06145 Community noticeboard

Concern was expressed about the state of the community noticeboard. It was decided to

place this on next month's agenda.

06146 Winter gritting service

Resolved: To defer a decision on whether or not to buy extra salt until the decision on upgrading priority of Daleside Road and Gill Lane had been received.

06147 Hydroelectric project

The Council noted an e-mail from the Hydrometry Team of the Environment Agency which

said that Head and Flow of the river was unknown. Councillor Jones said that there had been

hydroelectricity in Rosedale before and that she had contacted Mann Power who were excited

by the prospect.

Resolved: To ask the Esk Valley Hydroelectric Project to address the Council To attempt again to get the Hydroelectric companies to survey the area.

06148 Bus shelter

The Council heard that it was still waiting for a written response from the Community Group on this subject.

06149 Dog fouling

The Council heard that a new dog waste bin had been received by Streetscene ready to be

delivered and installed by the Caretaker.

Resolved: That information on dog fouling would be circulated among Councillors in order to decide a policy at the next meeting.

06150 Village clock

The Council heard that North Yorkshire County Council had advised that this issue be raised

with the National Park Authority, which the Clerk would now do.

06151 Publication of draft minutes

The Council noted advice from the Yorkshire Local Councils Association that it was

best

practice not to publish draft minutes.

A proposal to publish draft minutes at the same time as the agenda was defeated by seven

votes to three. Councillor Jones asked that her vote in favour of the proposal be recorded in

the minutes.

06152 Ryedale District Council review of polling districts, polling places and polling stations

Some Councillors had been unable to view the documents that had been e-mailed on

subject. The Clerk was instructed to send them again.

06153 Consultation to refresh the Sustainable Community Strategy for North Yorkshire

The Council noted receipt of this consultation.

06154 Resurfacing of road beyond Cropton

The Council heard that roads beyond Cropton were being resurfaced, even though there had

been no progress with roads in Rosedale.

Resolved: To invite Councillor Val Arnold to the next Council meeting to address this issue.

To confirm a recent phone call on the subject of Gill Lane in writing

To contact Highways about standing water in Alder Carr Lane.

06155 Emergency Planning Training

The Council noted this training day, to take place on 27 September. Councillor Storey said

she intended to attend.,

06156 Finance

Cheques were written for the Village Caretaker's August costs (£429.32) and the Clerk's

membership of the Society of Local Council Clerks (£72).

The Council noted the successful completion of the external audit. A cheque was written for

Mazars (£144) for this work.

The Council heard that under the new HMRC guidelines, the Clerk could still be paid by

cheque, and HMRC could be paid by cheque at the Post Office. The remainder of the Clerk's

invoice from 30 June was therefore settled, and cheques were written for the Clerk's net wages (£480.77) and to Post Office Ltd to pay HMRC (£121.62).

The Council resolved to renew its membership of the Campaign to Protect Rural England.

This is paid by direct debit so no cheque needed to be written.

06157 Planning applications received
