06285 Community Group update

06286 Minutes of previous meeting

06287 Village clock

The Council heard that the School Governors had no objection to a clock, provided they were not responsible for its maintenance.

06288 Broadband

The Council heard that the representative from BT had not responded in time to attend this meeting.

06289 Emergency Planning

Resolved: to contact Maggie Farey to find out how to proceed on this issue; to place details on how to claim compensation from Northern Powergrid in the newsletter again.

06290 Dog fouling

Resolved: to order a new dog waste bin for the car park at Milburn field; to place an item in the newsletter reminding people that children play on this field and that dog mess should always be removed;

to order leaflets on the subject from the National Park Authority for distribution with the newsletter.

06291 Walkers Are Welcome

The Council heard that Rosedale was now the first village in the National Park to gain Walkers Are Welcome accreditation.
