The water leak on Thorgill/Chimney Bank has an order raised for investigation and the follow up is under review

Kerb installation at Hill Cottages – the request has been turned down

Field entrances at Heygate Bank – incorrectly filled at edges, works order issued

Culverts – Hob House, engineer to inspect

Culverts - Thorgill Road – monitoring and NYCC advised that water is now over flowing onto the road

Verges on new surface on road from Rosedale to Egton

This is to be discussed with the maintenance manager again as the quality of the initial work regarding further rectification

New Road from Aimer Bridge Aimer House – road damage, other agencies have also been involved and notification of road flooding has been done, Natural England have requested a delay in repair due to green growth

Lights at Orange Tree – still in hands of RDC
