- 07156 The Council considered planning applications received from NYCC and NYMNPA since the previous meeting and note pending planning issues;

The Council received information from the beneficial owner of **7 Rosedale Abbey** regarding an ongoing land issue. The resident received a letter notifying her that a change of use had occurred on land owned by herself. Documentary evidence of continuing use as a garden were presented. Note was made of options available and a request was made for Parish Council opinion. The Council were provided with documentation in respect of the property sale in 1951 validating the resident claim.

The Parish Council commended the attractive approach following hard work by the new owner in her garden since the change in ownership over 2 years ago by the Rosedale sign complimenting the access to the Village. The Council felt that the contact made could create a disincentive to those wishing to maintain the visual impact. The Council requested the Clerk to write a letter of support for the hard work to bring the area back from a tip zone to an attractive visual amenity.
