for the Ordinary Meeting held at Rosedale Reading Rooms on Thursday 13 July 2017 at 7:00pm

- 07295 He Council received apologies for absence from Cllrs Brown, R Dent, Preistman and Scarth
- 07296 The Council received Declarations of Interest in items on the agenda; Cllr B Hebron re planning item
- O7297 The Council welcomed Mel Farnham, James Malcom, Peter Garnham of NYCC Highways and Dan Bentley of Ringways

Cllr T Dale started the discussions with a report of a meeting with P Garnham in the past week noting on going issues. Mr Mason reported the cost benefits of surface dressing in full repair.

The ford at Battling Hills is an ongoing problem where the ford has been raised but when the water and detritus blocks the piping and pushes water onto the road away from the river also flooding the footbridge. A suggestion of a topographical survey to understand the impact prior to further works.

The works newly completed Rosedale East to Blakey – road closures around Bank Holidays, the culvert piping is now not directly catching water fall off.

Dates of road closures and quality of signage was discussed including methodology of communications.

Cllr Dale raised the issue a "road" which is passable with limited vehicles – this road is now degenerating where farms are being flooded – this matter will be referred to Mr Jackson.
