<u>NYM/2018/0487/FL</u> construction of single storey orangery extension following demolition of store. Midge Hall Farm, Daleside Road, Rosedale East

The Council had no objections to this application.

<u>NYM/2018/0411/LB</u> Listed Building consent for alterations and construction of single storey extensions to domestic outbuilding. Woodlands Farm, Dale Side Road, Thorgill, Rosedale.

The Council unanimously supports the initial application which was in keeping with the natural surroundings and does not feel that the request for reversion is either economically feasible or practical in the reinstatement requirements. The council considers that the timber cladding would be detrimental to the traditional characteristics of the area.
